Dear Mr Walker,

Further to my letter of 25th January 2023, which was sent to both you and Mr Fernandes and which was passed to your colleague Helen Worth, who provided a spurious & specious letter of response to my requirement, dated 13th February 2023, delaying any redress.

Continuing with regard to Herefordshire Council's extensive and extended covert directed surveillance, I further insist that separate full detailed lawful justifications for each specific internet search and numerous visits to my family's websites and my social media for the following precise dates from all council networks and employee used connections are provided, to include individual specific, explicit and legitimate reason for visit, time of visit and duration spent on each access and viewing of the aforementioned, and this is provided without additional delay.

I am mindful that the below are not all dates of surveillance and sharing of data by Herefordshire Council staff, and should Herefordshire council care to admit or declare additional dates at this time, I suggest separate detailed lawful justification of specific, explicit and legitimate reasons are similarly included for each additional date along with IP addresses, including time spent on each access and viewing, so these can be examined against my records.
